## **A11I0135. Nurock Construction LLC v. Commercial Creations Incorporated.**

Nurock Construction LLC seeks interlocutory review of the trial court's December 9, 2010 order denying its motion to dismiss. Although the trial court signed a certificate of immediate review on December 19, 2010, it did not file the certificate until Tuesday, December 21, 2010, 12 days after entry of the order denying Nurock's motion.

Under OCGA § 5-6-34 (b), a party may request interlocutory review only if the trial court certifies within 10 days of entry of the order at issue that immediate review should be had. If the certificate of immediate review is not entered within that 10-day period, it is untimely, and the party seeking review must wait until final judgment to appeal. See OCGA § 5-6-34 (b); *Turner v. Harper*, 231 Ga. 175, 176 (200 SE2d 748) (1973); *Van Schallern v. Stanco*, 130 Ga. App. 687 (204 SE2d 317) (1974) (“[A] certificate of immediate review of a nonfinal or interlocutory judgment is ineffective unless entered, i.e., filed with the clerk, within ten days after entry of the judgment appealed from.”).

The trial court did not enter its certificate of immediate review within 10 days of the order Nurock seeks to appeal. Accordingly, we lack jurisdiction to consider this application for interlocutory appeal, which is hereby DISMISSED.



MG International, Inc. seeks interlocutory review of a December 14, 2010 order denying its motion to dismiss. The certificate of immediate review, however, was not entered until 16 days later, on December 30, 2010. Under OCGA § 5-6-34 (b), a party may request interlocutory review only if the trial court certifies within ten days of entry of the order at issue that immediate review should be had. If the certificate of immediate review is not entered within that ten-day period, it is untimely, and the party seeking review must wait until the final judgment to appeal. See OCGA § 5-6-34 (b); *Turner v. Harper*, 231 Ga. 175, 176 (200 SE2d 748) (1973). Here, although the trial court signed the certificate of immediate review “nunc pro tunc to Dec. 22, 2010,” the relevant date for determining the timeliness of the certificate is the date it was entered. See *Van Schallern v. Stanco*, 130 Ga. App. 687 (204 SE2d 317) (1974) (“[A] certificate for the immediate review of a nonfinal or interlocutory judgment is ineffective unless entered, i.e., filed with the clerk, within ten days after entry of the judgment appealed from.”).

Because the trial court did not enter the certificate of immediate review within ten days of entry of the order at issue, we lack jurisdiction to consider this application, which is hereby DISMISSED.





## **A1110151. OGLESBY et al. v. DEAL et al.**

Larry and Susan Deal, the alleged paternal grandparents of minor child G. L. D., petitioned for grandparent visitation after their son died. The defendant mother, Summer Nicole Thornburg, and the defendant maternal grandmother, Tina Marie Oglesby, moved to have the case dismissed for insufficiency of process, insufficiency of service of process, and lack of personal jurisdiction, or to have the case transferred to the Superior Court of Chatham County on grounds of improper venue. The trial court denied the motion, but granted a certificate of immediate review, and Oglesby and Thornburg filed this application for interlocutory appeal.

Under OCGA § 5-6-34 (a) (11), “[a]ll judgments or orders in child custody cases including, but not limited to, awarding or refusing to change child custody” are now directly appealable.<sup>1</sup> The effect of this broad language is that a party seeking to appeal any order in a child custody case – even a non-final order such as the one at issue here – is no longer required to comply with the interlocutory appeal procedure of OCGA § 5-6-34 (b) or the discretionary appeal procedure of OCGA § 5-6-35 (a) (2). See *Cohen v. Cohen*, 300 Ga. App. 7, 8 (1) (684 SE2d 94) (2009); *Taylor v. Curl*, 298 Ga. App. 45 (679 SE2d 80) (2009). Moreover, under Georgia law “[v]isitation is considered a custody issue.” *Daniels v. Barnes*, 289 Ga. App. 897, 899 n. 1 (658 SE2d 472) (2008); see also OCGA § 19-9-41 (4) (defining “child custody proceeding”

<sup>1</sup> The statute applies “to all child custody proceedings and modifications of child custody filed on or after January 1, 2008.” Ga. Laws 2007, p. 554, § 8. The Deals’ petition for grandparent visitation was filed on October 18, 2010, and thus comes within the statute.

as “a proceeding in which legal custody, physical custody, or visitation with respect to a child is an issue.”). Thus, the order that the applicants seeks to challenge is directly appealable.

“This Court will grant a timely application for interlocutory review if the order complained of is subject to direct appeal and the applicants have not otherwise filed a notice of appeal.” *Spivey v. Hembree*, 268 Ga. App. 485, 486 n. 1 (602 SE2d 246) (2004). This application for interlocutory appeal is therefore GRANTED. The applicants shall have ten days from the date of this order to file a notice of appeal in the superior court.<sup>2</sup> The clerk of the superior court is directed to include a copy of this order in the record transmitted to this Court.
