



BY CASE TYPE



## Caseload Statistics Reports

Caseload Workload Summary 19\_\_ through 20\_\_. (Covers a ten year period)

Disposition Statistical Summary Report - Counts Cases Disposed between two dates and includes the begin-date chosen and the end-date chosen.

The programs looks to see if there is a COA final judgment after the Supreme Court first in the time frame. If there is, it counts and collects that judgment. If that field is blank, it check the COA initial judgment field and if there is a judgment here it counts and collects it.

On the grand summary page of this report the following items are counted: Opinions, non-published opinions, companion cases and orders. It uses the following logic.

An opinion is counted if there is a judgment number, a greater than 0 opinion page count and the case status is either a J or R.

A companion case is counted if there is a judgment number, a 0 opinion page count and a J or R case status. Therefore, if you want to display total cases disposed by opinions, the companion cases need to be added to the cases disposed by opinion.

An order is counted if there is no judgment number, a 0 opinion page count and the case status is J or R. If this is true, the orders total is only orders that dispose of the case.

A non-published opinion is counted if there is a judgment number, a greater than 0 opinion page count but no data in the citation field and the case status is J or R. If this is true, non-published opinions will be counted in the total opinion count and this number should not be added to obtain total cases disposed by opinions.
